SUMMARY

- A. Application made for FireSmart Community Awareness Day 2021 through the SLBI Fire Committee.
- B. Notified by FireSmart Canada application approved March 1 2021. (Donation of Celebration day material and \$500.00 towards cleanup and Barbecue) Request for donations added \$1500.00 to our budget from a donation of North of 53 CO-OP Store.
- C. Notified SLBICA fire committee of grant and after discussion and committee specifically for this initiative was formed. **Wildfire Community Awareness Preparedness Day Committee** (North End / Blair Sapergia) (South End / Lynn Brown Ken Entwistle) (Point Road / Loretta Burke Greg Agerbak) (CreekSide BaySide / Rick Dansereau) (treasurer Menno Giesbrecht).
- D. Minutes committee Mtg Tuesday May 11 2021: The FireSmart program expects we promote three core objectives:
1. community involvement in cottage area cleanup
 2. Education on FireSmart strategies to reduce wildfire risks. Including how to use local fire fighting equipment.
 3. Community get together (Bar-Bque) to foster a community spirit.
- Our budget has sufficient funds to provide for the above objectives. We will require members of our committee organize a barbecue day, however the covid issue may have an impact on how large a crowd we can muster.

At present we are looking towards a day in July but will wait for conditions to play out.

Our cleanup effort does not require a large gathering of people at one time (covid rules), so can be done over time. We have started by having Hydro clear some of the more dangerous overhang removed so clearing can continue.

- E. Cleanup proved to be more enthusiastically embraced than organizers anticipated!!!
- F. Cleanup program started week May 17—22. Cleanup brush to be marshalled in three areas for efficient move to landfill later.
- G. Response from local community required increase in time involved in moving material to landfill. from 1 day to 3, and additional heavy equipment as well. Equipment Donated by Local Contractor : Whitford Paving.
- H. Some of the brush required Hydro crew remove branches and brush adjacent to hydro lines. Hydro rep arranged for material be dropped to the ground with local cottagers agreed to remove the debris to landfill.
- I. Committee set date of Sat July 31 2021 1-4pm. for Barbecue.
- J. Clear, bright day for celebration! Well attended (64 members). Training on fire equipment went very well,
- K. Final meeting of **Wildfire Community Awareness Preparedness Day** committee transferred remainder of funds to SLBICOA Fire committee and dissolved group. Aug 2021.
- L. Details of items listed above are presented below, including pictures etc. Communication to cottagers was done with email and posters.

WHERE IT ALL STARTED

Four years ago the Parks Manager indicated a a program to evaluate local cottagers fire readiness situation . This evaluation was centred around cottagers located in the provincial park however the information was made available to all local cottagers in the area

The information included an application from FireSmart for funds to support activity and awareness. At a spring meeting of the SLBI Fire committee a motion was passed to have our organization apply for this grant. This grant application was taken up by the Schist Lake Big Island Fire Committee. It required a few attempts and approval happened March 1 2021.

FINANCIAL

The grant from FireSmart Canada supplied us with written material guides , some T-shirts banners and \$500.00 to go towards food and drink for the barbecue. Approval required our organization to have a cleanup day followed by a barbecue. We were obligated to advertise FireSmart Canada and provide pictures to be submitted to their organization.

The grant money was deposited with the SLBI Cottage Association treasurer under our Fire committee account and was administered by our association treasurer.



Our group requested donations from local organizations with the Local North of 53 CO-OP providing \$1500.00.

cheque for \$1500.00 presented by Tom Therian on behave of Local CO-OP store.

Monthly Financial statements were provided during the initiative and when program was complete all funds were turned over to fire committee account.

North End: Blaire Sapergia

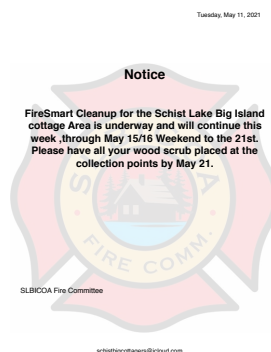
Southend: Lynn Brown, Ken Entwistle, Menno Geisbrecht (treasurer).

Their mandate was initiate a cleanup , and organize information meetings as well as a barbecue to complete project.

THE CLEANUP



A little history: A few years ago we had a severe wind storm which left a large amount of debris in our cottage areas. It required a concerted

effort by our neighbours to clear away the mess. A number of areas were cleared by moving piles of debris to vacant land to be cleared away later.

The Cleanup began with an assessment of all areas. It was decided that local areas would marshal their materials into three areas in order the heavy equipment being utilized would have less travel time after loading .

Manitoba Hydro were asked to clear some partially fallen trees to avoid possible accidents were locals to attempt this .



The reality was a bit different!



A local contractor was asked to donate a truck and loader for one day to move the debris piles to the local landfill. Whitford Paving Co, agreed to provide.

It should be noted that the original plan was to clear the material in one day with one truck and loader.

Community participation in the cleanup was fantastic! Each area having marshalled their debris for removal, collected quite a sizeable pile to remove.

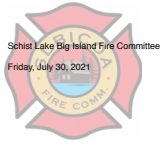
By the end of the first day Whitfords had moved some of the material but required two trucks and by the second day three trucks. After three days of work, including a long weekend, 58 tandem trucks of material had been removed. The areas were significantly enhanced by this effort from a safety and a aesthetic view.



The effort was a great example of community spirit that required a week of cleanup on each cottagers part and the collected pile of scrub being removed in three days. This left our community a much safer and aesthetically pleasing place to live. The effort included cleanup crews, coffee / baking station crews, traffic guides, and volunteer runabouts. The wildfire preparedness day (week actually) turned out to be a great success reflected by the great participation from our community members.

TRAINING THE MEMBERS



The training took place during our barbecue with the fire committee bringing our equipment to the site and setting up for members to try out.

All participants, young and old, had a great time trying to hit the target. Our experienced fire committee members provided the encouragement and instruction as well as some entertainment for the kids.

A floating dock was placed just offshore to provide a target for pointing accuracy. It was decorated with balloons to make it easier to focus. It proved to be a big hit.

It also gave our participants an idea of the capabilities of the various size pumps.

The members were shown how to set up the pump, attach the hoses (standardized throughout our



organization) start the pump and direct the spray towards the fire. An explanation of where to focus the water spray for effectiveness was included.

As part of the cleanup we will have heavy equipment on the area roads to load and haul the material to the landfill.

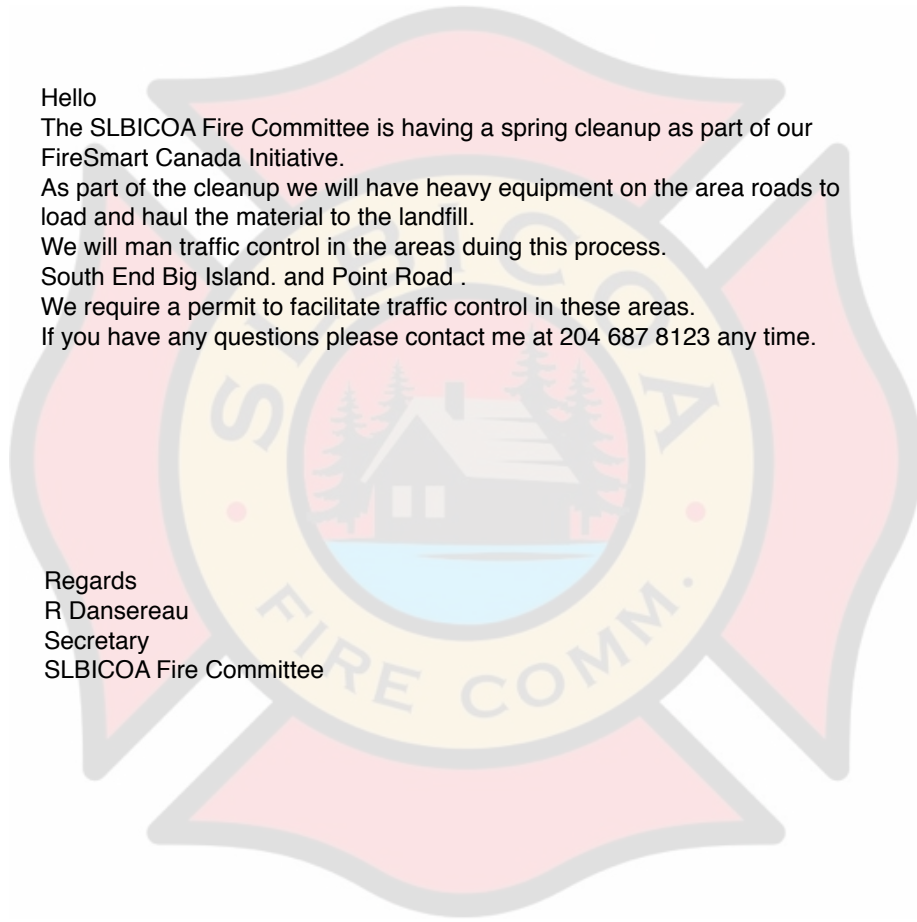
We will man traffic control in the areas during this process.

The following conditions are in addition to those conditions listed on the face of the work permit:

1. Existing trails, portages and other travel ways shall not be altered so as to interfere with other users.
2. The permittee will ensure that any work done in or near a waterbody is done in accordance with the **Manitoba Stream Crossing Guidelines for the Protection of Fish and Fish Habitat, May 1996**.
3. There shall be no bulldozing of vegetation into standing timber. Any vegetation and debris removed during the operation shall be piled and burned or compacted in windrows. Windrows shall be compacted to lie as close to the ground as possible (maximum height of 0.6 of a meter) and shall be no closer than 1 meter to the bush line. Burn piles must be located a minimum of 15 metres from standing timber.
4. For operations accessed by road or overland, the permittee shall locate fuel storage and equipment servicing areas a minimum distance of 100 metres from any waterbody.
5. The Conservation Officer in Cranberry Portage, 204-472-3331 shall be notified no less than one week prior to completion of operations to allow for final inspection of the operation.
6. All Operations must be completed to the approval of the local Conservation Officer.
7. When work has not begun within two weeks of the issuance of this permit, or if work is halted for more than one week, or if work is to begin in a new Sustainable Development district, the permittee must notify the district office prior to starting or restarting operations.
8. The local Conservation Officer on behalf of the Sustainable Development, shall have the authority to, at any time, amend or cancel this permit or to suspend operations, should non-compliance of any of the terms or conditions of this permit occur.

IMPORTANT: The Crown Lands Amendment Act assented to July 5th, 1994 states that failure to comply with the terms and conditions of a Work Permit issued under this Act is an offence punishable by a fine of up to \$10,000.

- Corrective action can be ordered at any time during or after the operation.
- You are responsible for the actions of your employees or contractors.
- The onus is on the Permittee (you) to comply with the terms and conditions of this permit.

1. Functional fire suppression equipment is required during the wildfire season, April 1 - November 15. The minimum requirements are dependent on the type of operation and are outlined below:

Road Construction: Each heavy equipment unit (crawler tractor, excavator, skid steer loader, graders) shall be equipped with a minimum of:

- ✓ •1 - 20 lb. ABC type fire extinguisher or 2 - 10 lb. ABC type fire extinguishers.
- 1 shovel.

✓ **Haulage Trucks:** Each truck engaged in log/gravel haulage shall be equipped with a minimum of:

- 1 - 5 lb. ABC type fire extinguisher.
- 1 shovel.

✓ **Service / Utility Vehicles:** Each service/utility vehicle such as pick-ups or fuel tenders shall be equipped with:

- 1 - 5 lb. ABC type fire extinguisher.

All Terrain Vehicles: Each all terrain vehicle shall be equipped with a minimum of:

- 1- 2.5 lb. ABC type fire extinguisher.

Power Saws / Brush Saws: Each power saw or power hand tool kit shall be equipped with a minimum of:

- ✓ •1 - 2.5 lb. ABC type fire extinguisher.

Logging Operations / Scarification: Each heavy equipment unit (skidder/slasher/forwarder/feller buncher) shall be equipped with in minimum of:

- 1 - 20 lb. ABC type fire extinguisher or equivalent.
- 1 pack pump (full) or equivalent container able to hold a minimum of 15 litres of water.
- 1 shovel.

Forest Camps / Work Crews (drilling / tree planting / line cutting, etc.): Each camp shall have the following minimum type of equipment on site:

2 - 4 Person Crew

- 1 pack pump (full) or equivalent container able to hold a minimum of 15 litres of water.
- 1 shovel.

5 - 9 Person Crew

- 2 pack cans (full) or equivalent container able to hold a minimum of 15 litres of water.
- 1 shovel.
- 1 axe.
